January 23, 2025 Meeting Minutes

Welcome/Introductions: Sara welcomed everyone.

Presentation: Alexa Waugh-Quasebarth and Alayna Waldrum presented on their program, Safe at Home with Home Care Partners. In 2011, the DC Falls Free Coalition began to advocate for environmental modification programs in DC. In 2017, funding was granted to Home Care Partners, for the program Safe at Home. DC residents can apply for the program. Their home will be assessed by an Occupation Therapist and then recommendations for improvements are made. Examples of modifications include handrails, grab bars and stair lifts. A contractor approved by Safe at Home will install the modifications. Additional funding was granted in 2022 to focus on falls risk education. This is known as Safe at Home 2.0. This program offers evidence-based falls risk classes, such as MOB and SAIL. There is no income requirement for this program and all classes are held virtually.

Grant Report/Updates: Sara gave updates on the current grant. We will conclude our second (of four) year in April. SAIL is at 300% of our grant goal. It is doing very well but we are always looking to train new SAIL leaders to keep the program going. The next SAIL Leader Training is on February 10th, 2025. MOB is only at 30-35% of the grant goal. MOB will be our focus this year to reach our goal. We need more coaches and workshops! The next MOB Coach Training is on February 19th, 2025. We will have more trainings in May. Sara reminded everyone about data collection. Please collect Pre and Post surveys as well as attendance. Data collection forms are changing soon. We will keep you posted. She discussed the target population, Saving Claire, and project dissemination efforts. We have the rights to the Saving Claire film through August. Falls Prevention Awareness week will be Sept 22-26, 2025.
